# Introduction

These release notes describe the new features and functionality that are introduced as part of Finastra's CreditQuest 23.1.1 and 23.1 releases. These notes cover both administration and the end-user side.

**IMPORTANT!** Before you install this release, ensure that you have performed all the required prerequisite steps as documented in "Prerequisites to your Upgrade" in *CreditQuest 23.1 Upgrade and Installation Guide*.

## CreditQuest 23.1.1 Hotfix

The CreditQuest 23.1.1 hotfix resolves issues that clients were experiencing when trying to install or upgrade with Exchange Server On-Premise. (See the [CQ-19926 / RFC 00532900](#) release note on page 2.)

## TransUnion Cloud Migration Information

TransUnion has made available a new Cloud version to their platform. This is now available for use in CreditQuest. As of now TransUnion has no plans to decommission their current services. In addition, the same certificate and subscriber code credentials will work in this new access.

Configuration changes will be needed in Table Manager, as well as additional configuration changes through Total-Lending Access which will allow CreditQuest to connect to TransUnion cloud services.

Additional system configuration information can be found in the *TransUnion Cloud Migration Guide* available in the Customer Success Community through Support Center – Solutions>CreditQuest>CreditQuest>Product Documentation>Current Release Documentation>CreditQuest 23.1.0 OpenPath.

**IMPORTANT!** It is important to follow and understand the cloud migration guide prior to upgrading to the TransUnion Cloud Services.

## Microsoft Windows Server 2012 and CreditQuest 23.3

**IMPORTANT!** The following does not apply to CreditQuest 23.1. It is an early warning of supported system changes that will be made in CreditQuest 23.3.

Effective with the CreditQuest 23.3 release, the following Microsoft products, which have been or will be decommissioned by Microsoft, will no longer be supported for use with CreditQuest 23.3:

- Windows Server 2012
- Windows Server 2012 R2
- SQL 2012 R2
- Microsoft Office 2013

Our recommendation is to upgrade to Windows Server 2016, which also upgrades the .NET Framework to 4.6. Please refer to Microsoft documentation for each product for further information and extensions.

The CreditQuest 23.3 release is targeted for the first week of September 2023. Prior to applying this release, please verify that all devices have been upgraded to a supported operating system and the CreditQuest Servers have been upgraded.

These changes are necessary because Microsoft officially retired support for Windows Server 2012 on July 12, 2022, and will retire 2012 R2 on October 10, 2023.

These tokens can be used on the command lines for launching LaserPro instead of the UserID. This secure process is not turned on by default and is only available for the properly set up users.  <b>Note:</b> Although this feature is available in CreditQuest 23.1 it is reliant on LaserPro functionality which is scheduled for a June 2023 release.
